NOTIFICATION

In order to implement the Prime Minister's Directives regarding the "Education Emergency", particularly Directive No. 7 and letter F. No. 1-1/2024-Sec FEPT dated May 21, 2024, issued by the Ministry of Federal Education and Professional Training under the Prime Minister's Roshan-Pakistan National Literacy Drive, Each One Teaches One (EOTO) initiative, and letter No. F.1-2/2024/Dir/(NCC) dated June 3, 2024, issued by the National Curriculum Council (NCC), the Federal Board of Intermediate and Secondary Education (FBISE) will award EOTO certificate having 10 marks to the students of SSC and HSSC Levels on the basis of certificate issued by National Commission for Human Development (NCHD) on successfully imparting Literacy and Numeracy Skills to an illiterate person (Learner). Following are the modalities:

- a. Heads of institutions affiliated with FBISE will submit undertaking along with EOTO certificate issued by NCHD on behalf of regular students at the time of sending their admission to the board for SSC-II and HSSC-II examinations to the effect that a particular student has successfully imparted Literacy and Numeracy Skills to an illiterate person (Learner) in his/her locality or as determined by his/her institution.
- b. On the basis of submission of the undertaking by the Principal concerned and EOTO certificate issued by NCHD, full credit (10 marks) will be given for task completion.
- c. A separate/ additional certificate based on EOTO initiative will be issued by the FBISE under the signature of Director Research & Academics to students individually.
- d. EOTO certificate will be issued only to SSC-II/HSSC-II pass students.
- e. For issuance of Certificates and other Communications, Registration number of FBISE allotted to students will be used by FBISE and NCHD both.
- f. FBISE may monitor the process of award of certificates issued to students by NCHD.
- g. Educational Institutions will coordinate with NCHD and NCC for the content and delivery of the EOTO course.
